- Purpose of the changes:

With continuing progress in asset sales and cost reduction, the Company is redirecting its key resources towards growing existing and new businesses.

<Finance, Advisory & International Division>

- The Company will merge the two sub-sections of the International Business Group in order to improve operational efficiency and build upon the steady progress made in the disposition of overseas investments.

- The Company will merge the Accounting & Tax and Business Planning & Investor
