Resolution 1: A majority of the total votes cast of shareholders attending the AGM must be in favor of the proposal.

Resolution 2: Shareholders representing no less than one-thirds (1/3) of exercisable voting rights of all shareholders must be in attendance, and two-thirds (2/3) or more of the total votes cast of such shareholders must be in favor of the proposal.

Resolution 3: Shareholders representing no less than one-thirds (1/3) of exercisable voting rights of all shareholders must be in attendance, and a majority of the total votes cast of such shareholders must be in favor of the proposal.
