## **Reorganization and Changes in Corporate Directors**

Ichigo Group Holdings Co., Ltd. ("Ichigo") approved today the reorganization of several key subsidiaries. In addition, subject to resolutions of shareholders' meetings and board of directors and approval from regulatory authorities, Ichigo nominated candidates for corporate directors and statutory executive officers.

- 1. Reorganization (effective July 1, 2012)
- (1) As announced in today's release, "Merger of Consolidated Subsidiaries," Ichigo Group Holdings Co., Ltd. ("Ichigo") approved today the reorganization of several key subsidiaries in order to further accelerate Ichigo's growth as an independent full-service real estate asset manager. As a result, Ichigo's holding company will become a pure holding company that retains a headquarters function.
- (2) In the merger between Ichigo REIT Management Co., Ltd. ("IRM") and Ichigo Real Estate Investment Advisors Co., Ltd. ("IRE"), IRM will be the surviving corporation and the company name will be changed to Ichigo Real Estate Investment Advisors Co., Ltd. ("New IRE"). In the merger between Ichigo Solutions Co., Ltd. ("ISL") and Ichigo Estate Co., Ltd. ("IES"), ISL will be the surviving corporation and the company name will be changed to Ichigo Estate Co., Ltd. ("New IES").
- 2. Corporate Directors (effective May 26, 2012)

As a Japanese firm that operates with a board committee structure, the majority of Ichigo's board members are independent external directors to strengthen corporate governance on behalf of all shareholders. Changes in corporate directors and statutory executive officers are as follows:






