2. Corporate Reorganization

i) Details of Reorganization

Effective March 1, 2015, Ichigo is reorganizing as follows to further increase its operating efficiency and fully achieve all of its <u>Shift Up 2016</u> Mid-Term Business Plan.

- a) The Real Estate Services Group, which heretofore provided real estate related-services internally, will be rebranded as the Real Estate Group expand its services to external clients and further drive earnings.
- b) The Compliance function will be moved into the Business Management Group and an Administration & HR team will be established by combining the Administration and HR teams.
