# Sale of Two Solar Power Plants

Ichigo decided today to sell two solar power plants (panel output: 3.6MW) to Ichigo Green Infrastructure Investment Corporation ("Ichigo Green," 9282).

1. Background

Ichigo Green invests in solar power plants with a mission to provide stable long-term returns for investors while contributing to the development of Japan's sustainable society.

To support Ichigo Green's EPS growth, Ichigo is selling Ichigo Green two solar power plants, the Ichigo Yamaguchi Aionishi ECO Power Plant (JPY 40 FIT (Feed-In Tariff)) and Ichigo Yamaguchi Sayama ECO Power Plant (JPY 36 FIT). Both solar power plants have been operating for over a year and can be expected to generate ongoing stable cash flows. As Ichigo Green currently does not have any solar power plants in Japan's Chugoku Region, today's transaction will further diversify its portfolio and minimize weather-related earnings volatility.

As Ichigo Green's sponsor, Ichigo is working to generate win-win outcomes for both Ichigo and Ichigo Green's shareholders. Ichigo's support for Ichigo Green includes developing a pipeline of reliable, high-performance solar power plants and ongoing power plant operation and management. Today's transaction will contribute to the growth of Ichigo's asset management business, expanding its stable earnings base and further increasing its capital efficiency.
