## **Launch of Ichigo THANKS! Monthly Present Program Ichigo Potager Fresh Lychee Gift Box**

Ichigo has ended the Ichigo J.League Shareholder Program following the conclusion of its J.League Top Partner agreement, as announced in the April 14, 2026 release “Conclusion of Ichigo J.League Shareholder Program & Launch of Ichigo THANKS! Monthly Present Program.”

We extend our heartfelt thanks to all shareholders who participated in and supported the program. As an expression of our ongoing appreciation for our shareholders, Ichigo is launching an Ichigo THANKS! Monthly Present program, in which Ichigo is offering 50 shareholders the opportunity every month to win special gifts from Ichigo’s agricultural business via lottery. This program is currently scheduled to run from June through December 2026.

On May 31, 2026 the current J.League Shareholder program website will be closed and replaced by the Ichigo THANKS! Monthly Present program website on June 1, 2026. Those who are already registered for the current program will not need to register again.

The first monthly present for June 2026 will be lychees grown by Ichigo’s subsidiary Ichigo Potager in Miyazaki Prefecture, which Ichigo is offering 50 shareholders the chance to win via lottery.



## 1. Ichigo Potager Fresh Lychees

Lychee cultivation in Japan is limited, and fresh domestic lychees can only be harvested for a few weeks. Ichigo is offering gift boxes of rare fresh lychees from Miyazaki Prefecture featuring specially selected large fruits weighing at least 50 grams each.

Ichigo Potager is committed to recycling local Miyazaki resources for its fertilizers, making use of unused resources such as bonito flake stock remnants from soba restaurants, kelp stock remnants from sushi restaurants, fermented bamboo fertilizers, and rice bran.

The gift boxes will feature the Chakapat lychee variety known for its exceptionally large fruits, grown using the carefully crafted fertilizers. We hope shareholders enjoy the juicy texture and rich, aromatic flavor that can only be experienced with fresh lychees.

### Ichigo Potager

Ichigo Potager grows strawberries, lychees, bananas, mangoes, peppers, and cacao in Miyazaki City, and engages in agriculture and food-related initiatives including café operations, D2C sales, product development, children's cafeteria operations, food education, development of new distribution services, and tie-ups with Ichigo's sports business.

### Eligible Shareholders

All Ichigo, Ichigo Office, Ichigo Hotel, and Ichigo Green shareholders recorded on the respective shareholder registries as of the fiscal period-ends are eligible.
